In the event that the Purchaser fails to notify Newell of additional information or decisions, and a delay in completing this Order could result, the Purchaser authorizes Newell to exercise Newell's best judgment in determining how to proceed so as not to delay completion of this Order.
4. Purchaser agrees to deliver to Newell negotiable title to any property traded in as a part of the consideration for the coach ordered hereunder at the time of delivery of such trade-in property to Newell. Purchaser warrants any such property to be his/her property, free and clear of all liens and encumbrances except as otherwise disclosed and noted herein. **SELLER FURTHER WARRANTS THAT THE TITLE FOR ANY SUCH TRADE-IN PROPERTY IS "CLEAR," AND CONTAINS NO WARNINGS OR NOTIFICATIONS SUCH AS "SALVAGE," "REBUILT," "JUNK," OR "REMANUFACTURED" UNLESS SUCH NOTIFICATION HAS BEEN DISCLOSED TO NEWELL IN WRITING AND ACCEPTED BY NEWELL IN WRITING PRIOR TO THE EXECUTION OF THIS CONTRACT. SHOULD PURCHASER BREACH THIS PROVISION, IT IS MUTUALLY AGREED BY NEWELL AND PURCHASER THAT THE TRADE-IN ALLOWANCE SHALL BE REDUCED BY FIFTY (50) PERCENT UNLESS OTHERWISE MUTUALLY AGREED.**

6. The price for the coach specified on the face of this Order does not include sales taxes, use taxes, or license fees. Purchaser agrees to assume sole responsibility for the full and proper payment of any and all such taxes and fees.
7. **NEWELL DISCLAIMS ALL EXPRESS AND IMPLIED WARRANTIES, INCLUDING THOSE OF FITNESS FOR A PARTICULAR PURPOSE AND MERCHANTABILITY. NEWELL SHALL NOT BE LIABLE FOR, AND NEITHER PURCHASER NOR ANY DIRECT OR REMOTE TRANSFEREE OF PURCHASER SHALL HAVE ANY RIGHT TO RECOVER FROM NEWELL, ANY CONSEQUENTIAL OR INCIDENTAL DAMAGES, INCLUDING WITHOUT LIMITATION, DAMAGES FOR LOSS OF USE, LOSS OF TIME, LOSS OF PROFITS OR INCOME, INCONVENIENCE, OR ANY OTHER DAMAGES, REGARDLESS OF WHETHER SUCH DAMAGES ARE CHARACTERIZED AS "CONSEQUENTIAL," "INCIDENTAL," "COMPENSATORY," OR OTHERWISE.**

DEPOSIT: IN THE EVENT THAT THE PURCHASER CANCELS THIS ORDER, OR DOES NOT TAKE DELIVERY AND PAY THE BALANCE DUE ON THIS ORDER WITHIN TEN DAYS AFTER NOTIFICATION BY NEWELL THAT THE COACH IS READY FOR DELIVERY, IT IS EXPRESSLY AGREED THAT NEWELL MAY COLLECT, FROM THE AMOUNTS PLACED ON DEPOSIT WITH NEWELL BY THE PURCHASER IN CASH OR TRADE-IN CREDITS OR UPON DEMAND, TEN (10) PERCENT OF TOTAL COACH PRICE SHOWN ABOVE AS LIQUIDATED DAMAGES. PURCHASER AND NEWELL AGREE THAT SUCH AMOUNT IS A REASONABLE AMOUNT FOR LIQUIDATED DAMAGES, AND THAT IT WOULD BE IMPRACTICAL OR EXTREMELY DIFFICULT TO FIX THE ACTUAL DAMAGES.

10. From time to time prior to completion of this Order and delivery of the coach, changes to the specifications or pricing may be made by mutual agreement of the Purchaser and Newell. Newell will document such changes by written Change Orders with a copy furnished to the Purchaser. Each Change Order shall be considered as accepted and agreed to by the Purchaser and shall become a part of this Order unless Purchaser notifies Newell to the contrary within ten (10) days of receiving said Change Order or Purchaser pays the final invoice, whichever is sooner.

11. Concurrent with delivery of the coach ordered hereunder, Newell will issue a final invoice to the Purchaser. Such invoice may reflect adjustments to the new coach price, or if a trade-in is a portion of the consideration, the difference price, made by mutual agreement of Newell and the Purchaser. Payment by the purchaser or his/her agent of the balance due as shown on such invoice shall indicate the agreement of the purchaser to the revised coach price as shown on such invoice. Further, if a trade-in is a portion of the consideration, the difference price shown on the invoice shall constitute the agreement between the Purchaser and Newell as to the amount thereof. Consistent with industry practice, any trade-in allowance shown on this Order or on the final invoice may be higher than the actual cash value of the trade-in. Purchaser and Newell agree that, in the event a dispute arises between the parties concerning this Order or if this Order is rescinded or terminated in whole or in part for any reason, the allowance for the trade-in may not represent the actual cash value of the trade-in. The parties agree that the actual cash value of the trade-in shall be calculated as the net resale price obtained by Newell less reconditioning and servicing at Newell's normal retail prices and less ten percent allowance for Newell's overhead and selling expenses.

12. CHOICE OF LAW, JURISDICTION AND ATTORNEYS' FEES: THIS ORDER AND THE OBLIGATIONS OF THE PARTIES ARISING HEREUNDER SHALL BE INTERPRETED, CONSTRUED, GOVERNED AND ENFORCED IN ACCORDANCE WITH THE LAWS OF THE STATE OF OKLAHOMA. THE PARTIES HERETO AGREE THAT THE EXCLUSIVE JURISDICTION AND VENUE FOR THE RESOLUTION OF ANY DISPUTE OF ANY KIND OR NATURE ARISING OUT OF OR IN CONNECTION WITH

THIS ORDER, INCLUDING BUT NOT LIMITED TO THE PERFORMANCE OR CLAIMED LACK OF PERFORMANCE OF ANY DUTIES OWED BY ANY PARTY UNDER THIS ORDER, ANY CLAIMED DEFECT(S) IN THE COACH WHICH IS THE SUBJECT OF THIS ORDER AND/OR ANY SERVICES CONNECTED THEREWITH, SHALL BE IN THE DISTRICT COURT IN AND FOR OTTAWA COUNTY, OKLAHOMA. IN ANY SUCH LAWSUIT, THE PARTIES AGREE THAT THE PREVAILING PARTY SHALL RECEIVE, IN ADDITION TO ALL OTHER DAMAGES WHICH SUCH PARTY MAY BE AWARDED, AN AWARD OF THE ATTORNEYS' FEES, COSTS AND LITIGATION EXPENSES INCURRED BY THE PREVAILING PARTY IN SUCH LAWSUIT.

13. Separability. If any provision of this Order is rendered or declared illegal or unenforceable, all other provisions of this Agreement shall remain in full force and effect.

14. This Order, together with Change Orders as described in paragraph 10 above, and the final invoice, as described in paragraph 11 above, comprise the entire agreement between the parties and supercede all prior agreements, discussions, representatives and negotiations, oral or written. This Order may be amended only by Change Orders and the final invoice described above, or a written amendment signed by all parties.

15. In the event of any controversy, claim, dispute, or litigation between the parties affecting or relating to the subject matter or performance of this Order, the prevailing party shall be entitled to recover from the nonprevailing party all of its reasonable expenses, including but not limited to attorneys' fees, witness fees, accountants' fees, and court costs.

This Coach Order and Price Schedule and Continuation Sheet, if any, together with the detailed drawings and change orders generated by Newell as a consequence of this Coach Order and Price Schedule, comprise the entire agreement affecting this purchase. No other agreement or understanding of any nature concerning this purchase has been made or entered into. Unless specifically agreed in writing to the contrary, the Purchaser hereby certifies that no credit has been extended to the Purchaser for the purchase of this motor coach. The Purchaser further certifies that he/she is of legal age and hereby acknowledges receipt of a copy of this Order.
